PESTICIDES/HEAVY METALS

Nutra Products nutraceutical garlic is randomly selected & tested for pesticides using a FDA/PAAM Method (commonly referred to as the Luke Procedure). The results of the screened compounds showed compliance with the pesticide list and tolerance levels approved for use in California. The pesticide list and tolerance levels are published by the California League of Food Processors. Individual lots were also screened for heavy metals using a Food Chemical Codex procedure. The screen included nine heavy metals: antimony, arsenic, bismuth, cadmium, copper, lead, mercury, silver, and tin. No heavy metals were detected.
